## 4. First-aid measures

### Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a poison center or doctor/physician if you feel unwell.

### Skin contact

## 5. Fire-fighting measures

### Suitable extinguishing media

Water fog. Alcohol resistant foam. Carbon dioxide (CO<sub>2</sub>). Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

<b>Specific hazards arising from the chemical</b>	Contents under pressure. Pressurized container may rupture when exposed to heat or flame. This product is a poor conductor of electricity and can become electrostatically charged. If sufficient charge is accumulated, ignition of flammable mixtures can occur. ## 6. Accidental release measures

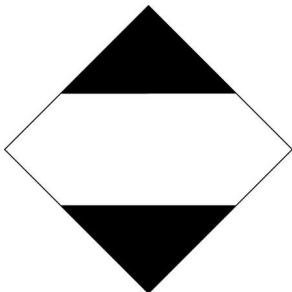
