### **4. FIRST AID MEASURES**

### **5. FIRE-FIGHTING MEASURES**

**FLAMMABLE CLASS:** This aerosol is NOT classified as FLAMMABLE by the flame extension test method described in 16 CFR 1500.45.

**EXTINGUISHING MEDIA:** Foam, carbon dioxide or dry chemical.

### **7. HANDLING AND STORAGE**

**GENERAL PROCEDURES:** Do not use or store near heat, sparks, open flame, or any other ignition sources.
